Berlin, October 14th 2025 // Swifty, the Al travel agent startup developed at Lufthansa Innovation Hub, was acquired by Revolut, a leading global fintech, in September 2025. The acquisition brings Swifty's booking platform and co-founders, Stanislav Bondarenko and Tomasz Przedmojski to Revolut, strengthening its position in agentic Al and travel technology.

From early bet to breakthrough: pioneering Al travel booking

Launched in the summer of 2023 out of Lufthansa Innovation Hub, Swifty is the first fully autonomous Al travel agent. Built on leading large language models (LLMs), it streamlines the core elements of business travel planning, including booking, payment, and invoicing through a seamless conversational interface.

Swifty marked Lufthansa Innovation Hub's move into agentic Al during its early days. Along the way, the venture has explored the potential of agentic Al in travel, generating valuable insights for future applications and business models.
